- Q1. If a regional dealer is awarded the contract, will it be able to assign the contract to other dealers of manufacturers they represent to sell products across the country utilizing this contract? Several other cooperative purchasing contracts allow this.
- A1. Responsive responses to the national contract capabilities of this RFP will include current capabilities to service the contract on a national level and not potential capabilities if awarded. Examples of responses including current capabilities in place to service a national award include but are not limited to; a manufacturer with national capabilities in place responding alone, a manufacturer partnering with local dealers to provide national services, and/or a group of local or regional dealers responding collectively to provide national coverage.**
- Q2. The RFP Paragraph 9.2 section e. states "Financial Statements: Offerors shall provide their most recent audited financial statement or balance sheet with their proposal submission". We are uncomfortable submitting our audited financials with the bid. Can something else be set up to allow someone from the FCPA to view these audited financials without submitting them with the bid? In lieu of this, would a letter of bondability along with a letter of financial wellbeing from our bank be sufficient?
- A2. Financial Statements will be accepted in any form provided that they include an Income Statement and Balance Sheet. Although not a mandatory requirement, we prefer that financial statements be audited and certified. Financial statements are being required to ensure that prospective contractors have the financial capability to fulfill the requirements of the contract on a national basis.**

- i. 2 – 5 Year Old Structure

 - o Would solar panels work or do you mean underground electric lines? – **The underground electrical will be performed by others.**






