<u>Answer:</u> A manufacturer specification sheet is allowed as an addition to the specification form, but the County would like the top part of the form to be filled out for each of the 10 models requested. Proposers may put "See Attachment" where the specifications portion begins if choosing this method of submittal. A link to the full price list or catalog is acceptable, or a digital file may be provided only on flash drive as well, but the paper copies must reference where the information can be found (in detail). A separate spreadsheet with the listed columns is acceptable. As stated in the RFP, the specification form is only required for the top 10 selling models that will be available under this contract.
