

Chances for NCAA-backed NIL bill depends on which senator you ask

WASHINGTON - A small baltroom's worth of ma-jor college athletic directors on 'Tuesday got a close-up view of the political landscape in Washington without having to go to Capitol Hill. At a hotel about two miles from their offices, they

Ted Cruz, R-Texas, said the belleved there was a "60-40" chance that Congress will pass a college sports bill that the ADs and NCAA officials have been hoping will bring some national order at least to athletes' activities in making money

Cruz is the ranking member of the Senate Com-merce Committee, which has jurtsdiction over this is-sue, and he told the LEAD Association's annual fall meeting that during a recent regular lunch with com-mittee chair Maria Cantwell, D-Wash, hey spent al-most half of the time discussing the NIL issue. But he added "that A0 is reat" most half of the time di added "that 40 is real."

added "that 40 is real." Soon thereafter, Sen. Chris Murphy, D-Conn., told the ADs: "I totally disagree (with Cruz's 60-40 as-sessment). I think there is very little chance" of a bill's passage, adding "it's not a priority issue for Congress."

Rep. Lori Trahan, D-Mass., noted dryly that, on Rep. Lori Truban, D-Mass., noted dryly that, on the House side, 'we literally cannot get the govern-ment funded" right now due to the wide range of po-litical turnoil. She then added that while Republi-cans may use their House majority push through a college sports bill from Rep. Murphy and Trahan have introduced their own bill called the 'Chilege Athlete Sconomic Freedom Act.' Trahan's comment was not long after Sen. I think that if there's so much money in the athletic departments and there's so much money coming in, you should at least pay for the kid's education. Their bill also would attempt to address what has become a massive shift in athlete movement among schools by generally rein athlete movement among schools by generally re-quiring athletes to complete three years of athletic el-igibility before they could transfer without having to slt out of competition for a year. There would be some exceptions, including for coaching changes. Under current NCAA rules, undergraduate ath-letes in any sport at a Division 1 school can transfer once at any time and be eligible to play immediately. While there are restrictions on athletes' ability to transfer more than once the NCAA here whime unce

transfer more than once, the NCAA has waiver p esses that generally have allowed them to make mul-



Cruz has officered a discussion draft of a bill that includes a provision that says college athletes shall not be considered an employee of an institution, con-ference or collegiste athletic association.

He said the concept of athletes as employees raises the prospect of "all sorts of problematic conse-quences," including the question of whether it would result in athletes being subject to getting fired for near performance.

But one athlete labor lawsuit is pending before the 3rd U.S. Circuit Court of Appeals. And the National Labor Relations Board's Los Angeles office is pursu-ing a completint against the NCAA, the Pac-12 Confer-ence and the University of Southern California. Against this backdrop, Murphy told the ADs: "I would argue for the NCAA to be couvening a conversation right now about what a revenue-shar-ing system would look like. To be thinking about, if not collective bargaining, a model where students actually have power and, instead of just being reac-tionnry – which is where the industry and where the CAA has been for decades – sort of understand that the courts are coming for the existing paradigm. And I don't think you can count on Congress to save you. "Think you've got to be thinking now about the wort of easi with what I think ultimately will be a require-ment to start treating student-athletes in a different way."






